**OPEN MEETING:** Open meeting at 7:03 available for public input for the 2023-2027 5 Year Recreation Open Space Master Plan, meeting closed by motion from Connie Allen, second by Steve Hinds with no additional input.

### Old Business:

- 2023-2027 5 Year Recreation Open Space Master Plan Motion to approve/accept S. Hines, 2<sup>nd</sup> D. Smitz, motion approved. That the Roscommon Area Recreation Authority adopts the Village of Roscommon, Higgins Township and Roscommon Area Recreation Authority Plan 2023-2027, as a guide for improving the recreation for the residents and visitors. Resolution will be signed and submitted.
- CRAF Center New doors and door wall installed at front of the building allowing public access to restrooms during community events. Fifteen thousand of the \$16,995 was funded by Roscommon DDA.
- 2023 Gazebo Concert Grant request submitted to MCACA by J. Klumpp for \$3,500 for 2023 concert series approved.
- AuSable River Center Reindeer Run / Baby It's Cold Outside Events to be held December 3, in conjunction with Christmas in the Village Saturday. Currently 48 signed up for Reindeer Run which will be held at 3:00 PM. Roscommon County Sheriff's Department will assist in street closures. Baby it's Cold Outside will begin at 7:00 PM, tickets \$15 per person, includes beer/wine, hors d'oeuvres from Beachwood Cafe, and entertainment. Note: Santa Train will be on the tracks in front of the ARC from 2:30 to 4:00 PM.
- Kitchen renovation is coming along; snowshoe, 2-day build a pair clinic, a great success; inside Farmers' Market / Craft venue inside, first one held November 19, great success. The Market will be held monthly throughout the winter. A suggestion was made to have a display of rental info available during ARC events/usage.
- Metro Park Plans submitted by Fleis & VanderBrink reviewed. Layout design includes parking, Pump Track, Splash Pad, hiking/walking trail. Estimated cost for the Pump Track 240,000, Splash Pad (2200 sq. ft.) \$170,000 pad, \$15,000 concrete pad. Hiking path of crushed aggregate. Estimated total pending. Grants will be partial funding source. Motion C. Allen, 2<sup>nd</sup> S. Hines to procure Pump Track engineering plans from Velo Solutions in the amount of \$9,000. Motion carried.

• Gahagan Nature Preserve – 34-Acre land acquisition to be placed in a conservation easement with Headwaters Land Conservancy.

New Business:

- CRAF Center Urgent restoration of COOR Classroom. Ceiling collapsed, usage moved to other areas until repairs are being completed. ServPro tested for asbestos and mold, all clear. We will replace drop ceiling using much of the existing material.
- CRAF Center Motion to increase hourly wages for CRAF Center employees to \$14 per hour by C. Allen, 2<sup>nd</sup> D. Hines, motion carried.
- RARA 2023 Meeting Dates: Thursday, February 2; Wednesday, March 15; Wednesday, May 17; Wednesday, July 19; Wednesday September 20; Wednesday, November 8.
